

Low noise JFET single operational amplifier

Features

- Wide common-mode (up to V_{CC}^+) and differential voltage range
- Low input bias and offset current
- Low noise $e_n = 15 \text{ nV}/\sqrt{\text{Hz}}$ (typ)
- Output short-circuit protection
- High input impedance JFET input stage
- Low harmonic distortion: 0.01% (typ)
- Internal frequency compensation
- Latch-up free operation
- High slew rate: 16 V / μs (typ)

Description

The TL071, TL071A and TL071B are high-speed JFET input single operational amplifiers. Each of these JFET input operational amplifiers incorporates well matched, high-voltage JFET and bipolar transistors in a monolithic integrated circuit.

The devices feature high slew rates, low input bias and offset currents, and low offset voltage temperature coefficient.



Figure 1. Circuit schematics





Figure 2. Input offset voltage null circuit

1. All voltage values, except differential voltage, are with respect to the zero reference level (ground) of the supply voltages where the zero reference level is the midpoint between V_{CC}⁺ and V_{CC}⁻.
2. The magnitude of the input voltage must never exceed the magnitude of the supply voltage or 15 volts, whichever is less.
3. Differential voltages are the non-inverting input terminal with respect to the inverting input terminal.
4. Short-circuits can cause excessive heating. Destructive dissipation can result from simultaneous short-circuits on all amplifiers.
5. R_{th} are typical values.
6. The output may be shorted to ground or to either supply. Temperature and/or supply voltages must be limited to ensure that the dissipation rating is not exceeded.
7. Human body model: 100pF discharged through a 1.5kΩ resistor between two pins of the device, done for all couples of pin combinations with other pins floating.
8. Machine model: a 200pF cap is charged to the specified voltage, then discharged directly between two pins of the device with no external series resistor (internal resistor < 5Ω), done for all couples of pin combinations with other pins floating.
9. Charged device model: all pins plus package are charged together to the specified voltage and then discharged directly to the ground.

Figure 3. Maximum peak-to-peak output voltage versus frequency




Figure 4. Maximum peak-to-peak output voltage versus frequency




Figure 5. Maximum peak-to-peak output voltage versus frequency




Figure 6. Maximum peak-to-peak output voltage versus free air temp.




Figure 7. Maximum peak-to-peak output voltage versus load resistance




Figure 8. Maximum peak-to-peak output voltage versus supply voltage




Figure 9. Input bias current versus free air temperature




Figure 10. Large signal differential voltage amplification versus free air temp.




Figure 11. Large signal differential voltage amplification and phase shift versus frequency




Figure 12. Total power dissipation versus free air temperature




Figure 13. Supply current per amplifier versus free air temperature




Figure 14. Common mode rejection ratio versus free air temperature




Figure 15. Voltage follower large signal pulse response




Figure 17. Equivalent input noise voltage versus frequency





Figure 16. Output voltage versus elapsed time

Figure 19. Voltage follower





Figure 20. Gain-of-10 inverting amplifier

Figure 21. (0.5Hz) Square wave oscillator





Figure 22. High Q notch filter
